In accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of personal data and to the free exchange of these data, And repealing Guidelines 95/46/EC (General Data Protection Regulation) (hereinafter, "GDPR"), you have several rights over your personal data, and how we handle these.

In accordance To the article 39 And 40 of there law no. 78-17 of 6 January 1978 relative To computing, to files and to freedoms, and to exercise your rights on your personal data, you must send the necessary elements to prove your identity, i.e. a copy of a valid proof of identity.

We would also like to remind you that the exercise of these rights may be limited depending on the grounds justifying the processing by the data controller. For example, your right to deletion is limited in the event that the data is necessary for the performance of a contract or a legal obligation .

☐ **Request to limit the processing of your data**, i.e., the case where you wish to restrict the processing carried out by the data controller and submit the handling of your personal data (exception made of archiving) to your prior consent (in accordance in Article 18 "Right to restriction of processing" of the GDPR). This request can only be made when :

- You dispute the accuracy of your personal data for a period allowing the data controller to check the accuracy of these data ;
- The processing is unlawful and you oppose the deletion of your data and demand the limitation of their use instead ;
- The data controller no longer requires your personal data but these are necessary for you to ascertain, exercise or defend your rights in court ;
- You oppose the processing as per the article 21, paragraph 1, of GDPR during the verification that conditions put forward by the data controller to justify the processing prevail over yours.
