In accordance with Articles 39(1) and 40(1) of Law No. 78-17 of 6 January 1978 on data processing, files and freedoms, in order for your request for access to your personal data and your request for the rectification of your personal data to be processed, you must provide the necessary documentation to verify your identity, namely a copy of a valid identity document.
